The National Asian Pacific Islander Prosecutors Association (“NAPIPA”) is proud to announce our 2024 Scholarship Awards. NAPIPA will award monetary scholarships + *Kaplan Bar Review Course* to three (3) deserving law students who share NAPIPA’s mission statement and goals and who are pursuing careers in prosecution to continue helping the API community.

Three (3) scholarships in the amount of \$2,500 and a **Kaplan Bar Review Course** for any State will be awarded to three (3) law students who showed a dedicated interest in public service.

In order to be eligible for these scholarships, you must be:

- 1) An enrolled law student as of September 21, 2024;
- 2) A member of NAPIPA (applications may be submitted contemporaneously with scholarship applications and can be found online at www.napipa.org – memberships dues are currently waived for this year); and
- 3) Personally present at the Scholarship Banquet on September 21, 2024 in San Jose, CA.

A scholarship application must include the following items:

- a. A completed and signed application form;
- b. Your current resume; and
- c. A personal statement of no more than two (2) pages, double-spaced, describing your interest in, commitment to, and any plans for a career in criminal prosecution, and your involvement with the API community. Please highlight why you want to be a prosecutor as well as specific instances where you have worked to help the API community.
- d. Letters of reference and any other supporting materials are optional but may also be considered at the scholarship committee’s discretion.

All application materials must be completed and received by **6:00 p.m. PST on Friday, August 30, 2024**. Please email all applications and any questions to Scholarships@NAPIPA.org.
